By law, the maximum contribution for a couple is \$17,400. That equates to \$2,900 per person per election. The first \$2,900 will be designated towards the 2022 Primary Election, the second \$2,900 will be designated to the 2022 Runoff, if one occurs, or the 2022 General Election and the third \$2,900 will be designated to the 2022 General Election. \$8,700 per individual and \$17,400 per couple. Federal multi-candidate PACs can contribute \$5,000 per election, or \$15,000 for all elections in 2022. Contributions from corporations, labor unions, foreign nationals (without "green cards") and federal government contractors are prohibited. Federal law requires us to use our best efforts to collect and report the name, address, occupation and name of employer of individuals whose aggregate contributions exceed \$200 per election. Contributions to Hullihan for Texas are not tax deductible.
